

Fraud within the UI system can occur against both a claimant (worker) and an employer. The following is a quick reference for reporting such fraudulent activity to a state UI agency. To clarify:

- Claimant fraud - to be used by an individual worker, who is the victim of identity theft, to report the incident to the UI agency or to report someone believed to be collecting fraudulently
- Employer fraud - to be used by any concerned party to report fraudulent activity being conducted by a company including worker misclassification
