Unemployment Insurance (UI) Information for COVID-19 Claims

Revised: 3/30/2020

At this time, most states are preparing for an increase in unemployment claims due to the COVID-19 pandemic; however in some cases they have not yet issued specific direction on claims based on disruptions caused by COVID-19. Currently, agencies are considering rule changes which may waive certain claim filing or weekly certification requirements as well as charging rules. Please be advised that if a field in the following chart is blank it means that we have not been made aware of a specific change or a decision made on that particular issue.
